A SPECIAL MESSAGE TO OUR EMPLOYEES

There seems to be considerable confusion with respect to the Company's proposals on the Hospital Plan and also on the incentive system. We will try to clarify this as follows:

HOSPITAL PLAN:

A deductible provision of \$75 has been added to avoid abure by some employees and to place some restraint on doctors who indiscriminately hospitalize employees, driving up everyone's costs. This \$75 applies toward and reduces the \$100 deductible in Major Medical.

For example:	Charges are:	Hospital Basic Plan Pays;
12 days in Hospital Room charge \$45,00 per day	= \$540	\$540
Hospital Extra charges (X-rays-Medication, etc.)	\$700	\$500
Surgical Charges	\$250	\$250
	\$1,490	\$1,290

This leaves \$200 yet to be paid as follows:

"The Company has offered to increase the Outpatient Diagnostic provision from the current \$50 to \$75." The following is an example:

Employee has diagnostic x-rays and lab tests as an outpatient amounting to \$75,00.

There also seems to be a misunderstanding regarding the Emergency provision of the Hospital Plan. If there is a need for this, the Hospital Plan pays for the first \$50 as it has in the past,

INCENTIVE SYSTEM

Our Incentive System over the years has eroded to where the standards cannot be applied fairly on many jobs. We are not saying all are loose or tight but in order to stay competitive and keep the work here at Bradley, we must be able to check these standards.

The Company's purpose is not to cut earnings. The company has stated "employees working at an incentive effort will not suffer a loss of earnings." The Company's real purpose is to increase productivity and become more competitive.
