CAN THE FAMILY FARMER STAY DOWN ON THE FARM

FAMILY farming is going out of business at the rate of at least 1,000 farms a week, according to U.S. Census Bureau figures. Often working the land instead are large corporations.

Farm land today is either owned or controlled by brewers, food companies, meat packers, oil companies and chemical firms, among others. Corporations own a good portion of farm land in California, Illinois and Iowa, says the National Catholic Rural Life Conference. And Tenneco-the oil and pipe conglomerate-is said to be our largest farmer.

PERSONNEL COMMUNIQUE

In line with the recent policy of increasing the maximum earnings subject to Social Security Taxes each year, a further increase will take place on January 1. 1977. Beginning on that date employees will have their wages taxed for Social Security up to a maximum of \$16,560 of earnings. This is an increase of \$1,260 over the current base for 1976 of \$15,300. The tax rate of 5.85 remains unchanged which means that there will be no increase in payments by those who earn less than \$15,300. However, those fortunate enough to earn the new maximum will pay a maximum of \$965.25 in Social Security taxes next year with a like amount paid by the employer. This is a \$70.20 boost from this year's maximum tax of \$895.05. The increase is brought about by the automatic escalator provisions contained in the Social Security Act, based on a formula designed to keep both contributions and benefits in line with rising average wage levels.
